Step 1: Baseline Knowledge

Citizenship is a Key Concept in the CSPE and Religious Education curriculum.

Development Education allows people to move from the basic awareness of global development priorities and sustainable human development, through learning and understanding the causes that global issues can have and how they can act to become involved.

Development Education is a life-long educational process which:

-gives information about people living in developing and developed countries and facilitates understanding the connection between their own lives and lives of people in the whole world.

-facilitates understanding of economic, social, political, environmental and cultural processes which influence the lives of all people.

-develops skills which enable people to solve problems actively.

-supports values and attitudes which enable people to take part in problem solving on local, --regional, national and international level.

-leads to accepting responsibility for creating a world where all people have the opportunity to live a dignified life, according to their own definition of what "dignity" means.

Social Justice Education:

Social justice is fairness and a mutual obligation in society: we are responsible for one another and we should have equal chances to succeed in life. (www.thersa.org) It is the view that everyone deserves equal economic, political and social rights and opportunities. (www.socialworkers.org)
